shall in no way be held to explain, modify, amplify, or aid in the interpretation, construction or meaning of the provisions of this lease.

and understood that all covenants and agreements herein made shall extend to and be binding upon the heirs, divisees, executors, administrators, successors in interest, and assigns of both the Landlords and Tenant, and that no modification of this lease shall be binding unless evidenced by an agreement in writing signed by Landlords and Tenant.
