An undivided one-third (1/3) interest in and to all that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the northeasterly side of Continental Drive, near the City of Greenville, S. C., being known and designated as Lot No. 76 on plat entitled "Map No. 1, Foxcroft Section II Final Plat Revised" as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4N, pages 36 and 37 and having according to said plat the following metes and bounds, to-wit:
