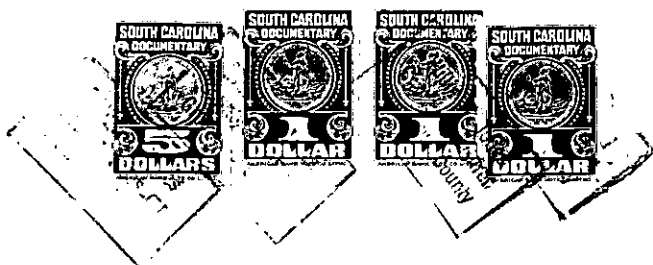
KNOW ALL MEN BY THESE PRESENTS, that I, William R. Wyatt, of Greenville County,
