Beginning at an iron pin on the western side of Lambourn Way, at the joint front corner of Lots 119 and 120, and running thence with the common line of said Lots S. 70-49 W. 218.8 feet to an iron pin; thence running N. 36-20 E. 108.0 feet to an iron pin; thence running N. 16-56 W. 85.0 feet to an iron pin at the joint rear corner of Lots 116 and 120; thence with the common line of said Lots N. 75-41 E. 142.4 feet to an iron pin on the western side of Lambourn Way; thence with the line of said Lambourn Way S. 13-42 E. 65.0 feet to an iron pin; thence continuing with said Lambourn Way S. 10-10 E. 50.0 feet to an iron pin; thence still with Lambourn Way S. 14-40 E. 20.0 feet to the point of beginning.
