

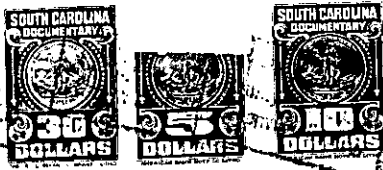

KNOW ALL MEN BY THESE PRESENTS That **Fortis Enterprises, Inc.**

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **Tracy B. Wrinkle and Lorraine M. Wrinkle, their heirs and assigns:**

All that piece, parcel or lot of land situate, lying and being on the southern side of Chaucer Parkway near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 11 as shown on a plat of Canterbury Subdivision, Section I, prepared by Heaner Engineering Co., Inc., dated March 22, 1972, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4-N at page 69, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southern side of Chaucer Parkway at the joint front corner of Lots Nos. 11 and 12 and running thence with the line of Lot No. 12 S. 01-45-34 E. 126.00 feet to an iron pin in the line of Lot No. 14; thence with the line of Lots Nos. 14 and 15 S. 85-08-00 W. 63.98 feet to an iron pin; thence continuing with the line of Lot No. 15 N. 81-37-00 W. 57.93 feet to an iron pin at the joint rear corner of Lot No. 11 and an unnumbered lot; thence with the line of said unnumbered lot N. 08-23-00 E. 130 feet to an iron pin on the southern side of Chaucer Parkway; thence with the curve of the southern side of Chaucer Parkway, the chord of which is S. 86-41-17 E. 98.40 feet to the point of beginning.

This conveyance is subject to all restrictions, zoning ordinances, setback lines, roadways, easements and rights-of-way, if any, affecting the above described property, including restrictions applicable to Canterbury Subdivision, Section I, recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 945 at page 109.
