the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto SYDNEY S. BERKOWITZ, His Heirs and Assigns, Forever: All my right, title and interest in and to

ALL that piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the major portion of Lot No. 1, Subdivision of Harold C. Gibson, as per plat thereof recorded in the RMC Office for Greenville County, South Carolina, in Plat Book X, page 44, and having, according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Westerly side of Oakview Drive, which iron pin is 445.3 feet in a Westerly direction from the Southwest intersection of Augusta Drive East and Oakview Drive, and running thence N. 47-33 W. 178 feet to an iron pin; thence S. 21-23 W. 161.5 feet to an iron pin; thence S. 68-37 E. 156.2 feet to an iron pin on the Westerly side of Oakview Drive; thence along the Westerly side of Oakview Drive N. 18-17 E. 57.3 feet to an iron pin; thence continuing along the Westerly side of Oakview Drive N. 38-30 E. 42.2 feet to an iron pin, the point of beginning.

This conveyance is made subject to any and all easements, rights of way and restrictions of record and as shown on said plat.

This being the same property conveyed by Sydney S. Berkowitz to Ruth K. Berkowitz by deed recorded in the RMC Office for Greenville County in Deed Book 423, at page 45. The said Ruth K.
