ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Zelma Drive, being known and designated as Lot No. 33, of a subdivision known as Oakland Terrace as shown on a plat thereof being recorded in the RMC Office for Greenville County in Plat Book BB at Page 196, and having, according to a plat of subdivision of Lots Nos. 31, 32 and 33 prepared by Jones & Sutherland Engineers dated February 12, 1959, the following metes and bounds, to-wit:
