GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS that I, Effie Gilstrap Myers, a legal resident of the County of Greenville, State of South Carolina, have made, constituted, and appointed, and hereby do make, constitute and appoint Annie Myers Tripp, my daughter, my true and lawful agent and attorney in fact to act in, manage, and conduct all my estate and all my affairs; and for that purpose for me and in my name, place and stead, and for my use and benefit and as my act and deed, to do and execute, or to conourwith persons jointly interested with myself in the doing or executing of, all or any of the following acts, deeds, and things, that is to say:

1. To buy, receive, lease, accept, or otherwise acquire; to sell, convey, mortgage, hypothecate, pledge, quit claim, or otherwise encumber or ~~dis~~ dispose of, or to contract or agree for the acquisition, disposal or encumbrance of; any property whatsoever and wheresoever situated, be it real, personal, mixed, or any custody, possession, interest, or right therein or pertaining thereto, upon such terms as my said attorney shall think proper.

2. To deposit and withdraw for the purposes hereof, in either my said attorney's name or my name or jointly in both our names, or jointly with any other person or persons, in or from any banking institution, or any other institution whatsoever, any funds, negotiable papers, or moneys which may come into my said attorney's hands as such attorney or which I now or hereafter may have on deposit or be entitled to.

GIVING AND GRANTING unto my said attorney full power and authority to perform all and very act and deed, matters and things whatsoever about my estate, property and affairs as fully and effectually to all intents and purposes as I might or could do in my own proper person if personally present, the above specifically enumerated powers being in aid and exemplification of the full, complete, and general powers herein and not in limitation of definition thereof; and hereby ratifying all that my said attorney shall lawfully do or cause to be done by virtue of these presents.
