KNOW ALL MEN BY THESE PRESENTS, that I, Donald E. Baltz

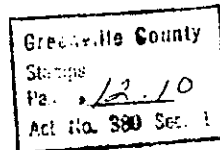
in consideration of Eleven Thousand (\$11,000.00) Dollars,

All that lot of land with the buildings and improvements thereon, situate on the north side of Fairfield Road near the city of Greenville, in Greenville County, S. C., being shown as Lot No. 22 on plat of Crestwood, Inc. made by J.C. Hill, Surveyor, February 28, 1949, recorded in the RMC Office for Greenville county, S. C. in Plat Book S page 189, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Fairfield Road at joint front corner of Lots 20 and 22 and running thence with the line of Lot 20, N. 1-05 W. 163.7 feet to an iron pin; thence N. 75-10 W. 75.5 feet to an iron pin; thence with the line of Lot 24, S. 3-25 E. 178.8 feet to an iron pin on the north side of Fairfield Road; thence with the north side of Fairfield Road S. 85-00 E. 65 feet to the beginning corner.
