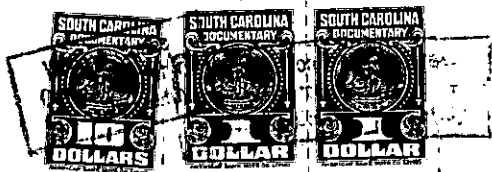
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southwesterly side of E. Woodburn Drive, being known and designated as Lot No. 22 on plat of Seven Oaks recorded in the RMC Office for Greenville County, S. C. in Plat Book 4R, at page 6, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of E. Woodburn Drive, said pin being the joint front corner of Lots 22 and 23 and running thence with the common line of said Lots S 59-31 W 207.7 feet to an iron pin, the joint rear corner of Lots 22 and 23; thence N 14-25 W 85.7 feet to an iron pin, the joint rear corner of Lots 21 and 22; thence with the common line of said Lots N 59-31 E 181.3 feet to an iron pin on the southwesterly side of E. Woodburn Drive; thence with the southwesterly side of E. Woodburn Drive S 30-29 E 90 feet to an iron pin, the point of beginning.

This conveyance is subject to a 25 foot sewer right of way, a 20 foot drainage easement and to all restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property.
