the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto David M. Boyer

ALL her one-half (1/2) undivided interest in and to all that lot of land with buildings and improvements thereon situate on the West side of Sherondale Lane, near the Town of Simpsonville, Austin Township, Greenville County, State of South Carolina, being shown as Lot 138 on a plat of Section II, Sheet II of Westwood Subdivision recorded in the R.M.C. Office for Greenville County, Plat Book 4F, at page 45, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Sherondale Lane, at the joint corner of Lots 137 and 138, and running thence along the line of Lot 137, N. 82-39 W., 161.7 feet to an iron pin; thence, S. 7-31 W., 158.1 feet to an iron pin; thence along the lines of Lots 140 and 139, N. 73-28 E., 202.1 feet to an iron pin on the West side of Sherondale Lane; thence with the curve of Sherondale Lane (the chord being N. 18-48 W., 13 feet) to an iron pin; thence continuing with the curve of Sherondale Lane, (the chord being N. 8-08 W., 67 feet) to the beginning corner.

This being the same property conveyed to the grantor and grantee by deed recorded in Deed Book 916, at page 15 in the R.M.C. Office for Greenville County, South Carolina.

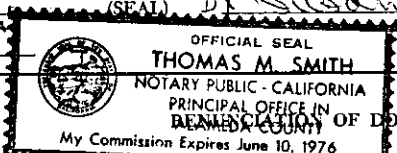
