Carlisle, III and Margaret Carlisle, their heirs and assigns forever,

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, Chick Springs Township in Taylors, and being known as Lot 55 on a plat recorded in Plat Book JJJ at page 10 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:
