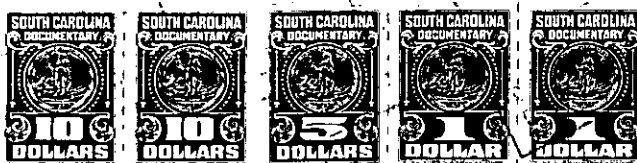

All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the southern side of Potomac Avenue, being known and designated as Lot No. 231, as shown on a Plat of Pleasant Valley, recorded in the R. M. C. Office for Greenville County, in Plat Book "P", at Page 93, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Potomac Avenue, at the joint front corner of Lots 231 and 232, and running thence with the common line of said Lots S. 0-08 E. 160 feet to an iron pin; thence running S. 89-52 W. 60 feet to an iron pin at the joint rear corner of Lots 230 and 231; thence with the common line of said Lots N. 0-08 W. 160 feet to an iron pin on the southern side of Potomac Avenue; thence with the line of said Potomac Avenue N. 89-52 E. 60 feet to the point of beginning.
