CORRECTIVE DEED

KNOW ALL MEN BY THESE PRESENTS That M. G. PROFFITT, INC.

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina; for and in consideration of the sum of One and No/100 (\$1.00) Dollar and correction of deed to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto COTHRAN & DARBY BUILDERS, INC., its successors and assigns forever, an undivided one-third (1/3) interest in and to:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Chippendale Court, near the City of Greenville, S. C., being known and designated as Lot No. 68 on plat entitled "Revised Plat of Lot 68 and 69 Map No. 1 Section Two of Foxcroft Subdivision" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4U, page 137 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Chippendale Court, said pin being the joint front corner of Lots 67 and 68 and running thence with the common line of said lots S 68-36 W 194.8 feet to an iron pin, the joint rear corner of Lots 67 and 68; thence S 57-20 E 68 feet to an iron pin; thence S 56-30 E 85 feet to an iron pin; thence S 74-45 E 128 feet to an iron pin, the joint rear corner of Lots 68 and 69; thence with the common line of said lots N 2-13 W 156.2 feet to an iron pin on the southerly side of Chippendale Court; thence with the southerly side of Chippendale Court on a curve the chord of which is N 88-38 W 20.5 feet; thence continuing on a curve the chord of which is N 53-40 W 54 feet to an iron pin, the point of beginning.
