in consideration of Twenty-One Thousand and no/100 (\$21,000.00) -----Dollars,

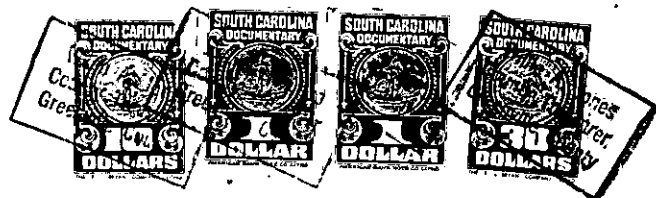
