All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the westerly side of East Woodburn Drive, near the City of Greenville, S. C., being known and designated as Lot No. 24 on plat entitled "Seven Oaks" as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4R, at page 6 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of East Woodburn Drive, said pin being the joint front corner of Lots 24 and 25 and running thence with the common line of said Lots N 51-58 W 185.4 feet to an iron pin, the joint rear corner of Lots 24 and 25; thence N 59-31 E 171.4 feet to an iron pin on the southwesterly side of East Woodburn Drive; thence with the southwesterly side of East Woodburn Drive S 30-29 E 18 feet to an iron pin; thence S 24-48 E 67.7 feet to an iron pin; thence S 13-26 E 67.6 feet to an iron pin; thence S 35-41 W 34.4 feet to an iron pin; thence S 48-41 W 46.2 feet to an iron pin, the point of beginning.
