Upon payment of all indebtedness of the undersigned to Eank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatess, devisess, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns.
