Section 202 ; the same being described and designated as above, in accordance with plat recorded in
R. M. C. Office for Greenville County in Plat Book TTT page 109 and in Plat Book TTT Page 111.

It is distinctly understood that said lot is to be used exclusively for the burial of human bodies of the white
race, and is sold and conveyed subject to all rules and regulations printed on the back hereof, and any addi-
tions or amendments for the government of the Cemetery which may hereafter be adopted.

TO HAVE AND TO HOLD the above granted property to the said Hugh K. Aiken, Jr. and
Clairene H. Aiken, their
heirs and assigns forever; subject, however, to the restrictions and limitations above referred to.

said premises to the said Hugh K. Aiken, Jr. and Clairene H. Aiken, their heirs and assigns
against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same
or any part thereof; subject, however, to the restrictions and limitations herein contained.
