C., in Plat Book EE, at Pages 64 and 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Park Drive, at joint front corner of Lots 66 and 67; thence with the southeastern side of Park Drive N 48-30 E 191.2 feet to a point in center of Horse Pin Creek (an iron pin is located 26.6 feet southwest of said point on southeastern side of said Park Drive); thence down and with the center line of said creek, the chord of which is S 49-15 E 83.2 feet to point in center of said creek; thence continuing with the chord of said Horse Pin Creek N 88-15 E 92.3 feet to point in center of said creek at joint rear corner of Lots 65 and 66 (an iron pin is located on rear line of said Lot 66, a distance of 44 feet southwest of said point); thence with the rear line of Lot 66 S 57-37 W 178.7 feet to an iron pin; continuing with rear line of Lot 66 S 21-51 W 109 feet to an iron pin at the joint rear corner of Lots 66 and 68; running thence with line of Lot 67 N 41-30 W 161.7 feet to an iron pin, the point of beginning.
