MEMORANDUM OF LEASE

Office for Greenville County in Plats Book J, at Page 37, and also being known and designated and more fully described, according to a plat entitled "Lease to TeleVision Communications, Inc.", dated November 29, 1972, and prepared by Campbell & Clarkson Surveyors, Inc., and having, according to the latter plat, the following metes and bounds, to-wit:
