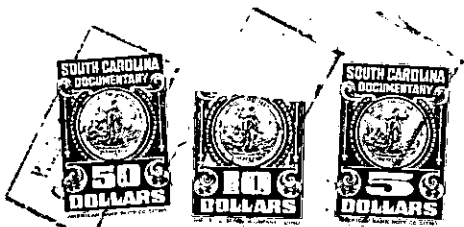
in consideration of Thirty-two Thousand Five Hundred (\$32,500.00) ----- Dollars,

Beginning at an iron pin on the southwest side of Richwood Drive, the joint front corner of Lots 19 & 20; thence with the joint line of said lots S. 36-44 W. 96.4 feet to an iron pin corner of Lot No. 18; thence with the rear line of said lot S. 86-44 W. 105.8 feet to an iron pin; thence with a new line through lot 20, N. 37-01 E. 158.45 feet to an iron pin on the southwest side of Richwood Drive, the joint front corner of Lots 20 & 21; thence with the southwest side of said street S. 59-20 E. 18 feet to a point; thence continuing S. 56-45 E. 62 feet to the beginning corner.
