All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, lying on the northeast side of Montclair Road, and being shown and designated as Lot No. 152, on a plat of Section III of Montclair, prepared by R. B. Bruce, dated April 17, 1969, and recorded in the RMC Office for Greenville County in Plat Book "WWW", at Page 57, and having, according to said plat, the following courses and bounds to wit:

BEGINNING at an iron pin on the northeast side of Montclair Road at the joint front corner of Lots Nos. 152 and 153 and running thence with the common line of said lots N. 60-37 W. 265.0 feet to an iron pin; thence N. 27-38 E. 75 feet to an iron pin at the joint rear corner of Lots Nos. 151 and 152; thence with the common line of said lots S. 60-37 E. 267.7 feet to an iron pin on the northeast side of Montclair Road; thence with said road S. 29-18 W. 80 feet to an iron pin, the point of BEGINNING.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground, along with tap fees, set back lines, and zoning regulations.

As a part of the consideration, grantee assumes and agrees to pay the balance due on that certain mortgage to First Federal Savings & Loan Association of Greenville, S. C., which mortgage is recorded in the RMC Office for Greenville County, S. C., on which there is a balance due of \$16,894.64.

Grantor hereby transfers and assigns to grantee the insurance policy and escrow account in connection with the above loan.

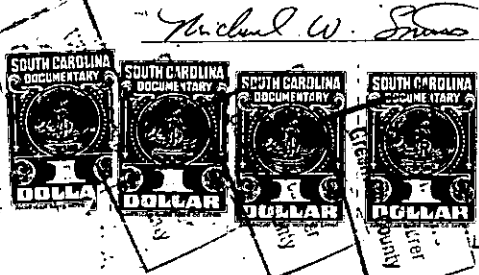
TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining
