

PARCEL III: All that certain piece, parcel, or lot of land, situate, lying, and being in the City of Greenwood, County of Greenwood, State of South Carolina, being known and designated as Lot No. "A" on a plat showing subdivision of lot of the Estate of W. H. Whitlock, made by E. S. Ethridge, C. E., dated September 28, 1955. The said Lot No. "A" fronts on the northwestern side of Taggart Street a distance of sixty-six (66) feet, and runs back therefrom on the northeastern side in a broken line a distance of two hundred seventy-six and 7/10 (276.7) feet and on the southwestern side a distance of two hundred seventy-six and 8/10 (276.8) feet, and is seventy-nine and 2/10 (79.2) feet wide in the rear, and is bounded as follows: On the Northeast by Lot No. "B" of said plat; on the Southeast by Taggart Street; on the Southwest by property now or formerly of Ellenberg; and on the Northwest by property now or formerly of Barnette. This is the identical property conveyed to Mary Ida Turner Rodgers and Virginia G. Turner, Individually, by deed of Virginia G. Turner, as Trustee under the Will of Olin Turner, deceased.

PARCEL IV: All and singular that certain lot or parcel of land containing four and one-half (4½) acres, more or less, situate, lying, and being in the Breezewood Section, School District No. 50, of Greenwood County, and bounded as follows: On the North by a public road; on the East by lands of Clarence Luquire; West by lands of Cook's and perhaps others. The said lot or parcel of land is triangular in shape and is more particularly described by reference to a plat made by Thomas C. Anderson, Engineer, dated March 23, 1923. This is the identical lot or parcel of land that was conveyed to Olin Turner, deceased by deed of John R. Weaghtington, dated November 12, 1953, and recorded in Deed Book 103, at Page 51.

PARCEL V: All that certain tract or parcel of land situate in the Town of Starr, Varennes Township, Anderson County, South Carolina, containing five and 88/100 (5.88) acres, more or less, and bounded now or formerly as follows: On the East by lands owned by the Palmetto Corporation; on the North by lands of W. E. Gunnin; on the South by lot of Bank of Anderson; and West by lands of C. T. Bowie.

ALSO: All that certain tract of land situate in Anderson County, State of South Carolina, in Varennes Township, containing five and 13/100 (5.13) acres, adjoining property, now or formerly, of W. M. Strickland, W. L. Mouchet, and others.

PARCEL VI: All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying, and being in the State of South Carolina, County of Greenville, in Saluda Township, containing four and 85/100 (4.85) acres, and being located on the southeastern side of S. C. Highway No. 11, approximately 640 feet southwest of the intersection of Air Line Road and being partially shown on a plat without a named owner made by C. C.
