An undivided one-third (1/3) interest in and to -

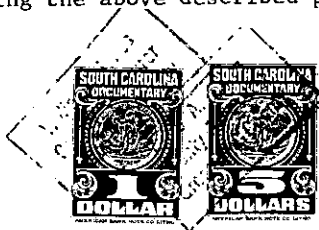
