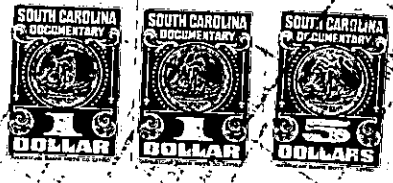
JACK McCALL and MARY R. McCALL, their heirs and assigns, forever:
