the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Margaret D. Biggers, her heirs and assigns, all our right, title and interest in and to:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina; County of Greenville and in Greenville Township, on the southeast side of West Faris Road, and being known and designated as Lot No. 105, of a subdivision known as Augusta Circle, as shown on plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "F" at Page 23, and having, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of West Faris Road at the joint corner of Lots Nos. 104 and 105, which point is 149.88 feet southwest from the corner of Faris Road and Winyah Street, and running thence along the joint line of Lots Nos. 104 and 105, S. 71-35 E. 129.7 feet to an iron pin; thence S. 21-35 W. 50 feet to an iron pin joint rear corner of Lots Nos. 105 and 106; thence along the joint line of said Lots, N. 71-35 W. 130 feet to the joint corner of said Lots on the southeast side of West Faris Road; thence along the line of said Road, N. 21-55 E. 50 feet to the beginning corner.
