In consideration of One Thousand Six Hundred Fifty (\$1,650.00) Dollars,

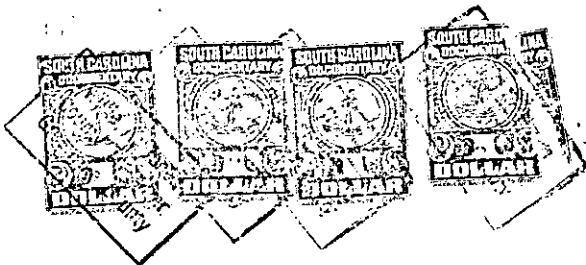
