the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John D. Vaulton, Jr., his heirs and assigns, forever:

ALL that piece, parcel or lot of land situate, lying and being in Chick Springs Township, County of Greenville, State of South Carolina, on the north side of Belvue Road (formerly known as Pine Street), and being known and designated as Lot No. 1 of the property of Ruth G. Butler, as shown on plat made by W. I. Riddle, August, 1946, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book Q, at Page 1, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Belvue Road (formerly known as Pine Street), at the corner of property formerly belonging to Thomas W. Butler, which is approximately 563 feet east of the intersection of the Old Rutherford Road; thence along the line of that property N. 38-57 E., 334 ft. to an iron pin at the rear corner of Lot 15; thence along the rear line of Lots 15 and 14, S. 45-33 E., 122.8 ft. to an iron pin at the rear corner of Lot No. 2; thence with the line of Lot No. 2, S. 42-30 W., 330 feet to an iron pin at the corner of said lot on the north side of Belvue Road (formerly known as Pine Street); thence continuing along with the line of said Road, N. 46-30 W., 100 feet to the beginning corner:
