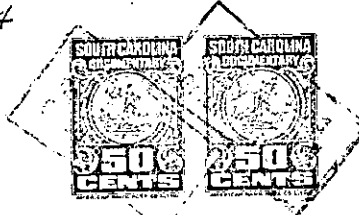
in consideration of One Hundred Twenty-Five and No/100 (\$125.00) Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James Lewis, his heirs and assigns forever:

All my right, title and interest in and to, the same being an undivided 1/51st interest, the following described real estate: All that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, and having the following metes and bounds, to-wit:

BEGINNING at a stone on the east side of Rutherford Road and running thence N. 6 E. 8.28 chains to an iron pin on Rutherford Road; thence N. 47 1/4 W. 13.35 chains to stone; thence N. 31 1/4 E. 3.70 chains to a stone; thence S. 47 1/4 W. 6.36 chains to an iron pin; thence S. 45 3/4 W. 3.33 chains to an iron pin; thence S. 34 W. 3.18 chains to an iron pin; thence S. 31 1/4 E. 10.28 chains to a stone; thence S. 47 1/2 E. 31.40 chains to a stone, the point of beginning, and containing 17 acres, more or less, according to survey made by J. Earle Freeman, September 1943.

An undivided 2/17 interest in said property was conveyed to Alfred C. Lewis by deed of John Lewis, et al. recorded in the R.M.C. Office for Greenville County in Deed Vol. 266 at page 196. The said Alfred C. Lewis died intestate in January, 1968, leaving as his heirs at law his widow, Katherine I. Lewis, and four children, Emma Taylor, Gladys Crawford, Alfred Lewis, Jr., and Kathryn Edmonds. Each of these heirs at law has conveyed his or her interest to James Lewis by separate deed.
