James Lewis, his heirs and assigns forever:

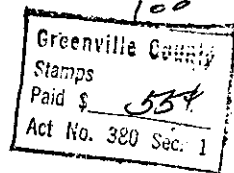
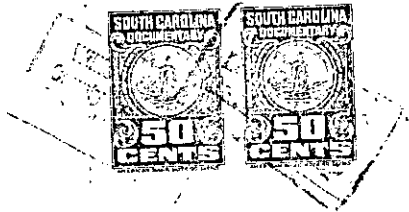
