"All that piece, parcel or lot of land situate, lying, and being in the State of South Carolina, and the County of Greenville, Oneal Township, located about two miles North of the City of Greer, being shown and designated on a plat of property made by Carolina Engineering & Surveying Co., 4/12/73, for the Grantees herein and according to said survey has the following courses and distances:

BEGINNING at a pin on the North side of C C Camp Road and running thence N. 10-45 W. 235.5 feet to an iron pin, thence N. 79-15 E. 182.5 feet to an iron pin, thence S. 7-20 E. 248 feet to an iron pin on the bank of C C Camp Road, thence S. 83-20 W. approximately 180 feet to the point of beginning, and containing according to said plat 1 acre, more or less.

This is a portion of the same property as conveyed to the Grantors herein by deed of G. L. Belcher, said deed dated January 24, 1973, and being duly recorded in the Office of R.M.C. for said County in deed book 966 at page 46.

The Grantees, their heirs and assigns forever, are hereby granted a right-of-way of ingress and egress along the western side of the above described property for a width of 25 feet and extending the length of said property for the use of a drive-way from the C C Camp Road."
