## ASSIGNMENT OF OPTION AND LEASE

THIS ASSIGNMENT OF OPTION AND LEASE, made as of this 1st day of May, 1973, by and between GREENVILLE PROPERTIES, INC., a North Carolina corporation (hereinafter designated as "Seller") and H. Dulin of 550 Strawberry Lane, Matthews, North Carolina and Mrs. Lois A. Dulin of 2600 Belvedere Avenue, Charlotte, North Carolina and Robert D. Culbertson of 638 Museum Circle, Charlotte, North Carolina and Richard B. Babcock of 3722 Beersford Road, Charlotte, North Carolina (hereinafter collectively designated as "Purchasers");

## WITNESSETH:

WHEREAS, pursuant to a certain Option and Lease (the "Land Lease") dated June 10, 1968, H. Perrin Anderson and Vernon T. WHEREAS, Seller desires to assign and Purchasers agree to accept Seller's right, title, and interest in and to the Land Lease as amended;
