 unto David E. Williams and Rosemary B. Williams, their heirs and assigns forever,

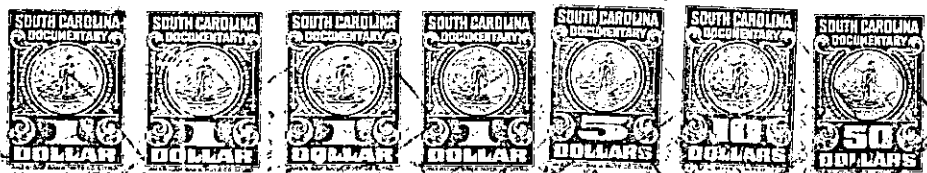
