Cromer by deed dated May 25, 1954, of record in Deed Book 500, page 350, in the R.M.C. Office for Greenville County, S. C., and the description of said lands as contained therein is incorporated herein by reference.
- (d) That certain tract of land containing 2.6 acres, more or less, conveyed by Forsyth Aggregates, Inc., to Bowman Gray, Gordon Gray, Neely J. Cromer and Dorothy C. Cromer by deed dated May 25, 1954, of record in Deed Book 500, page 367, in the R.M.C. Office for Greenville County, S. C., and the description of said lands as contained therein is incorporated herein by reference.
- (e) That certain tract of land containing 2.1 acres, more or less, conveyed by Forsyth Aggregates, Inc., to Bowman Gray, Gordon Gray, Neely J. Cromer and Dorothy C. Cromer by deed dated May 25, 1954, of record in Deed Book 500, page 353, in the R.M.C. Office for Greenville County, S. C., and the description of said lands as contained therein is incorporated herein by reference.
- (f) That certain tract of land containing 3.3 acres, more or less, conveyed by William Claude Smith and Jesse B. Smith to the Lessors, or their predecessors in interest, by deed dated October 16, 1955, of record in Deed Book 564, page 26, in the R.M.C. Office for Greenville County, S. C., and the description of said lands as contained therein is incorporated herein by reference.
- (g) That certain tract of land containing 4.75 acres, more or less, conveyed by J. O. Ernest to the Lessors, or their predecessors in interest, by deed dated March 29, 1956, of record in Deed Book 549, page 330, in the R.M.C. Office for Greenville County, S. C., and the description of said lands as contained therein is incorporated herein by reference.

Also as a part of this lease agreement and for its duration, or until the expiration of the hereinafter described easements and rights-of-way, whichever first occurs, the Lessors hereby grant unto the Lessee all of their right and privilege in and to the following:

(a) That certain easement and right-of-way transferred and assigned by Forsyth Aggregates, Inc., to Bowman Gray, Gordon Gray, Neely J. Cromer and Dorothy C. Cromer by written instrument dated May 25, 1954, of record in Deed Book 500, page 370, in the R.M.C. Office for Greenville County, S. C., which is incorporated herein by reference. The Lessors' easement and right-of-way on this, the H. C. Davidson tract, expires on June 9, 2003.
