in consideration of Five Thousand and No/100 (\$5,000.00) ----- Dollars,

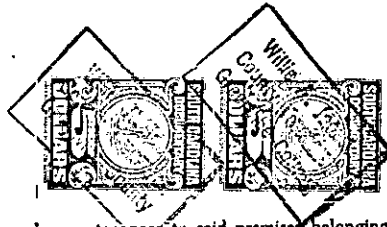
