All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the easterly side of Chick Springs Road, in the City of Greenville, S. 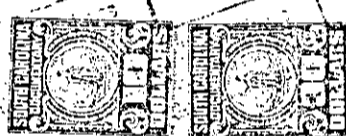

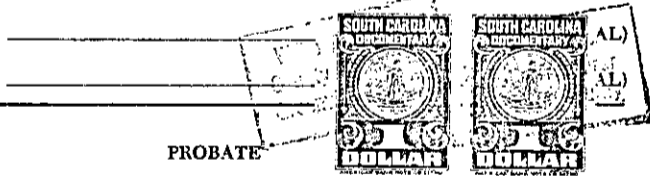
