 to John J. Fisher in hand paid at and before the sealing of these Presents, by John J. Fisher of aforesaid State and County  
 (the receipt whereof is hereby acknowledged), have granted, bargained,  
 sold and released, and by these Presents do grant, bargain, sell and release unto the said John J. Fisher,</sup>

all that tract or parcel of land lying partly in Spartanburg and  
 partly in Greenville Counties Beginning on a stone in Lindsey Prentiss  
 line running S 53° E 3.96 to Oak thence S 40 1/2 E 2.78 to Pine knot thence  
 S 24° W 8.75 to stake or stone in line thence N 83 W 16° to Mulberry  
 thence S 64 1/2 W 11.47 to Bush at spring thence S 82 W 2.60 to fork of ditch  
 thence S 37 1/2 W 4.12 to stone thence N 74 W 5.25 to stone on river thence up  
 said river to N.C. line S 72 E 10.90 to small poplar and stone in field thence N 64 W  
 E to the beginning, containing 2 1/8 acres more or less.
