"ALL that piece, parcel or lot of land just outside of city limits of Greenville, near White Horse Road on Easley Highway #29, in subdivision known as Rolando Bills, according to plat made by Piedmont Engineering Company, July, 1950, recorded in R.M.C. Office for Greenville County, in plat book "AA", at page 71, said lots being numbers 13, 21, and 22 of Block C, and being more particularly described as follows:
