

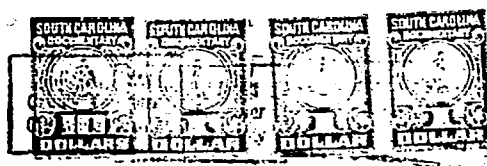

Zinkann, her heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the northeastern side of Rivendell Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 26 as shown on a plat of Trollingwood, Section 1, Revised, prepared by Enwright Associates and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at pages 12 and 13, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the northeastern side of Rivendell Drive at the joint front corner of Lots Nos. 26 and 27 and running thence along Rivendell Drive N. 49-06 W. 150 feet to an iron pin; thence continuing along Rivendell Drive N. 35-02 W. 30 feet to an iron pin at the joint front corner of Lots Nos. 25 and 26; thence turning and running along the line of Lot No. 25 S. 59-47 W. 249.4 feet to an iron pin at the joint rear corner of Lots Nos. 25 and 26; thence turning and running S. 55-04 E. 99.7 feet to an iron pin at the joint rear corner of Lots Nos. 26 and 27; thence turning and running along the line of Lot No. 27 S. 41-05 W. 253.6 feet to the point of beginning.
