OWENS D. JENNIFER and KATH G. JENNIFER, their heirs and assigns, forever:

All of that unnumbered parcel of land bounded on the north by Langston Creek, on the east by Tindal Road, on the south by Glenmore Drive and on the west by Lot No. 10 in the County of Greenville, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of the unnumbered tract herein conveyed and Lot No. 10, and running thence along the line of Lot No. 10, N. 33-39 E. 186.6 feet to an iron pin on the bank of Langston Creek; thence on the same course 12 feet to the bank of Langston Creek; thence on the same course 12 feet to the center of said creek; thence following the center of the creek as the line along the meanders of said creek to its intersection with Tindal Road; thence along Tindal Road in a southerly direction to the curved intersection of Glenmore Drive to a point on the northern side of Glenmore Drive; thence with the northern side of Glenmore Drive, S. 76-15 W. 130 feet, more or less, to a point; thence continuing along the northeastern side of Glenmore Drive, 150 feet, more or less, to the point of beginning. 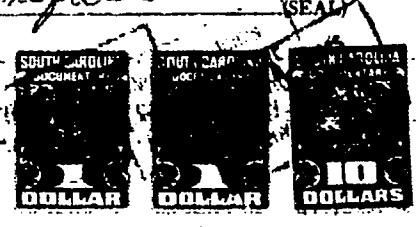
