in consideration of Thirty Four Thousand and no/100 (\$34,000.00) ----- Dollars,

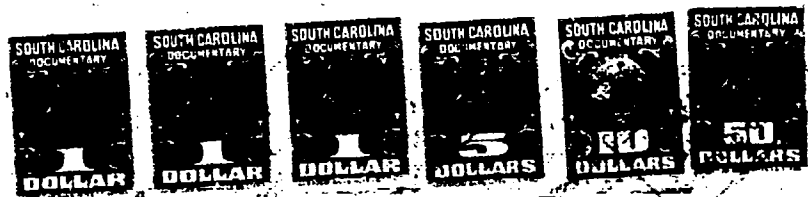
