BEGINNING at an iron pin on the southwest side of Highland Drive in the front line of lot # 59, said pin being 175.7 feet in a northwesterly direction from the point where the southwest side of Highland Drive intersects with the northwest side of Waccamaw Avenue and running thence through lot # 59 S. 48-50 W. 192.1 feet to iron pin; thence N. 41-10 W. 110 feet to iron pin; thence with line of lot # 57 N. 48-50 E. 192.1 feet to iron pin on the southwest side of Highland Drive; thence along the southwest side of Highland Drive S. 41-10 E. 110 feet to the beginning corner

B. Martin according to Plat recorded in Plat Book F, page 102 in the R. M. C. office for Greenville County, and being more particularly described as follows:

BEGINNING at a point on the southwest side of Highland Drive, said point being 120.7 feet from the corner of Highland Drive and Waccamaw Avenue and running thence S. 48-50 W. 192.1 feet to line of property owned by Meyers; thence along the Meyers line N. 41-10 W. 55 feet to a point on the rear line of lot # 59 as shown on Plat; thence N. 48-50 E. 192.1 feet to a point on the side of Highland Drive; thence along Highland Drive S. 41-10 E. 55 feet to the point of beginning.
