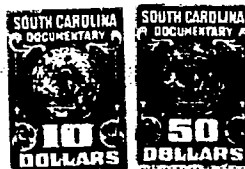
KNOW ALL MEN BY THESE PRESENTS, that T. Frank Huguenin, Jr.
