WHEREAS, William E. Crawford, Kathleen C. Pitman and Mary C. Williams, hereinafter referred to as grantors, are the owners of a lot of land situate on the Northwestern side of U. S. Highway No. 29 near the City of Greenville, in the County of Greenville, State of South Carolina; and

WHEREAS, Haverty Furniture Companies, Inc., hereinafter referred to as grantee, has acquired a lot from the Bishop of Charleston situate on the Northwestern side of U.S. Highway No. 29 and adjacent to the lot of the grantors herein; and

WHEREAS, an examination of the title to the property acquired by the grantee herein reveals that the grantors may have an interest in a portion thereof by way of easement and the grantee may have an interest by way of easement in a strip lying adjacent to the property of the grantee; and the grantors herein and the grantee herein desire to exchange deeds conveying whatever interest each may have in the adjoining properties; NOW THEREFORE

KNOW ALL MEN BY THESE PRESENTS, That we, William E. Crawford, Kathleen C. Pitman and Mary C. Williams

in the State aforesaid, in consideration of the sum of one (\$1.00) Dollar and other valuable consideration

to us in hand paid at and before the sealing of these presents by Haverty Furniture Companies, Inc.

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Haverty Furniture Companies, Inc. all the right, title and interest of the grantors herein, in and to:

All that piece, parcel or strip of land being 13 feet in width situate, lying and being, on the Northwestern side of U. S. Highway No. 29 near the City of Greenville, in the County of Greenville, State of South Carolina and being described as follows:

BEGINNING at a point on the Northwestern edge of the right-of-way for U. S. Highway No. 29 at the Southwestern corner of the property acquired by the grantee herein from the Bishop of Charleston and running thence in a Northwesteasterly direction 207.7 feet, more or less, to a point; thence turning in a Southwesteasterly direction 13 feet, more or less, to a point; thence running in a Southeasteasterly direction 207.7 feet, more or less, to a point on the Northwestern edge of the right-of-way for U. S. Highway No. 29; thence with the Southeastern edge of said right-of-way 13 feet, more or less, to the beginning point.
