A One-Half (1/2) interest in my One-Half (1/2) undivided interest in and to that certain piece, parcel or tract of land which is shown and designated as Property of Douglas Green, et al, according to a plat prepared by John A. Simmons, R.L.S., dated March 16, 1973, and having, according to said plat, the following metes and bounds, to-wit:
