All that piece, parcel or tract of land, situate, lying and being on the Southwest side of Paris Mountain in Paris Mountain Township, Greenville County, South Carolina, and having, according to a survey made by Campbell and Clarkson Surveyors, dated December 27, 1968, the following metes and bounds, to wit:
