all that certain piece, parcel or lot of land in Greenville Township,
Greenville County, State of South Carolina, being known and
designated as lot No. 11 on Plat of White Horse Addition, ne r
White Horse home, made by J. C. Hill, May 15, 1951, and having,
according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Evelyn Drive, joint
corner of lots Nos. 11 and 12, and running thence with line of lot
No. 12, S. 77-40 W., 200 ft. to an iron pin in the line of lot No. 14;
thence with the line of lot No. 14, 69.4 feet to an iron pin on the
