All that lot of land in Paris Mountain Township, Greenville County, State of South Carolina, near the Duncan Chapel Road, being a portion of the J. E. Thackston homeplace and being known and designated as Lot 18 on plat known as "Map No. 2, Montague Circle" Property of D. B. Tripp as per plat and survey by C. O. Riddle, R. L. S., April 1954, recorded in the R. M. C. Office for Greenville County in Plat Book GG at Page 51 and having the following metes and bounds, according to said plat:

BEGINNING at an iron pin on the southeastern side of Montague Circle (at edge of a 8-foot strip reserved for sidewalk) at corner of Lot 19 on said plat and running thence with the line of Lot 19, S. 70-40 E. 237.7 feet to an iron pin on edge of 30-foot alley reserved for service and utilities; thence with said alley, N. 15-24 E. 100.3 feet to an iron pin at corner of Lot 17; thence with the line of Lot 17, N. 70-40 W. 230.8 feet to an iron pin on edge of Montague Circle; thence with Montague Circle, S. 19-20 W. 100 feet to the beginning corner; being the same conveyed to me by D. 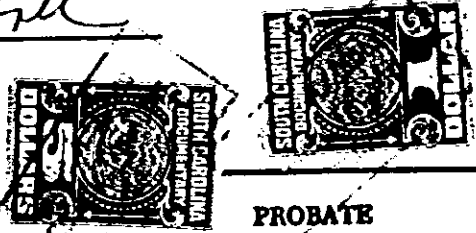
