In consideration of such loans and indebtedness as shall be made by or become due to FIRST PIEDMONT BANK AND TRUST (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree as follows:

1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below

2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein

3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howscever for or on account of that certain real property situated in the County of

Greenville , State of South Carolina, described as follows:

All that certain piece, parcel or lot of land on the southwestern side of Roper Mountain Road and having, according to plat recorded in Plat Book HHH at page 31, the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of Roper Mountain Road at the northeastern corner of the premises herein conveyed and running thence with Roper Mountain Road, N 37-42 W 90.3 feet to pin; thence continuing N 45-63 W 100 feet to pin; thence continuing N 52-35 W 100 feet; thence N 61-03 W 58.1 feet to pin; thence S 5-45 E 444.6 feet to pin; thence N 44-35 E 314 feet to the point Said premises being the same conveyed to the grantor by deed recorded in Deed Book 754 at page 103.

and hereby irrevicably authorize and direct all lessees, escrew holders and others to pay to Bank, all rent and all other monies whatsoever and shenspever becoming due to the undersigned, or any of them, and howscever for or on account of said real property, and hereby irrevocably appoint Bank, as attorney in fact, with full power and authority, in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive, receipt for and to enforce payment, by suit or otherwise, of all said rents and sums; but agrees that Bank shall have no obligation so to do, or to perform or discharge any obligation, duty or liability of the undersigned in connection therewith.

4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining ungaid grinting and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.

5. That bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to Dank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benetit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may applies hereby authorized to rely thereon.
