The operation, management and use of the property for such purposes shall be under the exclusive control of the Board of Directors of the Young Men's Christian Association of Greater Greenville, S.C., and the Trustee shall have no duties, responsibilities or obligations with respect to such operations, management and use except to carry out the directions of the Board of Directors of the Young Men's Christian Association of Greater Greenville, S.C.

Neither this provision nor any other provision contained herein shall be construed to prohibit (a) the temporary leasing of portions of said property to third parties
